11. Discuss/Action – Certify all corrections of error under state law (Sec 70.43, Wis Stats)
12. Discuss/Action – Verify with the assessor that open book changes are included in the assessment roll
13. Allow taxpayers to examine assessment data
14. During the first two hours, consideration of:
 - *Waivers of the required 48-hour notice of intent to file an objection when there is good cause
 - *Requests for waiver of the BOR hearing allowing the property owner to appeal directly to circuit court
 - *Act on any other legally allowed/required Board of Review matters
15. Review Notices of Intent to File Objection, if applicable
16. Proceed to hear objections, if any and if proper notice/waivers given unless scheduled for another date
17. Consider/act on scheduling additional Board of Review Date(s)
18. Adjourn (to future date if necessary)
